## Terms and Conditions

**1. The Service Provider will provide a fully qualified PIPA Inspector to carry out safety inspections of inflatables to the current BS EN 14960 (all parts) and any Technical Data Sheets provided by the PIPA Scheme**

- 1.1 All inflatables covered by the PIPA Scheme will be inspected under the PIPA Scheme and Inspection Reports issued under the PIPA Scheme.
- 1.2 PIPA Inspection Reports will be completed on the PIPA website within 14 days of the inspection being completed and will be sent via automated email.
- 1.3 PIPA tags will be fixed to an inflatable on an Initial Inspection prior to the commencement of the inspection.
- 1.4 All inflatables not covered by the PIPA Scheme will be inspected using the relevant parts of BSEN 14960, manufacturers or supplier instructions, historical data and experience. The Service Provider will provide their own Inspection Report.
- 1.5 Inflatable Testing And Training Service Inspection Reports will be completed in house within 14 days of the inspection/s being completed and will be sent via email as a PDF attachment to the Client.

# INSPECTION AGREEMENT


- 1.6 Any units failing an inspection will be logged as FAILED until the required repairs/modifications are carried out
- 1.7 Full payment is due on completion of the inspection or within 14 days of receipt of invoice. Unless a prior arrangement is agreed.
- 1.8 Payment may be made in cash, cheque, BACS (preferred) or PayPal. Bank details etc will be on the invoice.
- 1.9 PIPA Inspection Reports will be completed on the PIPA website within 14 days of the inspection being completed and will be sent via automated email.
- 1.10 Inspection Reports will not be issued until full payment is received. Unless by prior arrangement
- 1.11 Inflatable Testing and Training Service and its inspectors must abide by the PIPA scheme rules.
- 1.12 BS EN 14960-1:2019 covers inflatables that are bounce or slid on BS EN 14960-2:2019 covers Air Pillows BS EN14960-3:2020 covers Snappies.

## 2. The Client agrees to

- 2.1 provide a safe environment for the inspection of inflatables. Inspector must be able to view all external sides.
- 2.2 provide suitable parking for one vehicle.
- 2.3 provide a Wi-Fi connection if possible.
- 2.4 arrange for the erection and deflation of inflatables.
- 2.5 ensure inflatables are fully inflated.
- 2.6 ensure inflatables are dry and clean.
- 2.7 ensure any ancillary equipment is provided for inspection.

## 3. General

- 3.1 This agreement may be terminated by either party by giving 30 days notice, prior to date of inspection, in writing to the other and no penalties will apply.
- 3.2 Termination less than 30 days may incur a 50% charge of the agreed fee. This charge will be offset should the booking be arranged for a future date.
- 3.3 Cancellation due to weather conditions will be agreed on the date of booked inspection
- 3.4 Fee quoted will include travel, accommodation, Test Reports and PIPA Tags.
- 3.5 Fee quoted is based on information provided by the Client at the time of booking.
